Though 7<sup>th</sup> CPC pay and allowances have been implemented to the Central Government employees all over India way back w.e.f January 2016 and July 2017 respectively, the staff of Navodaya Vidyalaya Samiti have been unreasonably neglected. We are increasingly getting apprehensive about the prospects of getting our rights as employees of Central autonomous organization which contributes matchless service in nation building. We are denied equality of justice under constitutional provisions and hence this is a contravention to natural justice. Further, the unprecedented delay is causing monetary loss to every individual employee. Despite the fact that NVS has adopted all CCS rules this discriminatory approach of the government is a rude shock.

Hence AINVSA has decided to call up on all the employees of NVS to observe a **nation wide black badge protest** on **17<sup>th</sup> February,2017** if the allowances and arrears are not paid on or before 10<sup>th</sup> February 2017.
