Sub : Grant of Recognition to AINVSA as per CCS Rules-reg.

Sir,

All india Navodaya Vidyalaya Staff Association (AINVSA) is the service association registered in 1994 and has been functioning for the welfare of all staff without categorisation or discrimination and for the progress of NVS.

It is explicitly evident that to ensure democratic participation in decision making, the recognition of AINVSA is inevitable. We have attempted to get recognition for AINVSA in 2001. Consequently NVS has taken initiatives to process recognition through the procedures under check off system of verification. However the process was discontinued for no known reason. For the queries, we had submitted under RTI Act2005, we continued to receive the encouraging reply that the process was underway. But even after 10 years we have not been given any convincing reason for the discontinuance of recognition procedure.

Meanwhile, Shri. L. B. Reddy who was selected as the Gen. Secretary of AINVSA in 2005; was removed from the post as he was found to have a very strong leaning to a political party and was trying to hijack the association for their ulterior motives. Moreover on auditing the AINVSA account, misappropriation was also found. Nonetheless, Shri LB Reddy floated a splinter group and started running the association parallel to AINVSA with the same registration number but under a false restored head quarters and slight modification in the registration. It was also found that he had served you show cause notice to furnish reasons for failure in recognition for the membership he had submitted to NVS under the authority of the splinter group. He had also collected huge amounts for various functions. It is so respectfully stated that a membership fee was also deducted from the series of staff and kept with the Vidyalaya as unaccounted fund. Such an exercise is in contravention to the rules.

Hence we would like to know from your good self the authority under which such deductions were made and the details of the amount till the last date of such subscription. Also kindly furnish the status of the fund. Kindly clarify whether membership could be collected before the completion of check off system of verification.
