Sub. : Observation of **Black Badge Protest** in all JNVs and Administrative Offices of  
NVS demanding speedy release of **7 CPC arrears and allowances** to NVS  
employees

Madam/Sir,

We are passing through a very embarrassing situation with regard to the inordinate delay in the release of 7 CPC arrears and implementation of the new allowances as per 7 CPC recommendations. This situation is totally unprecedented and unheard of while considering all the previous Pay Commissions which were implemented equally and simultaneously to all central autonomous bodies together with CG employees without any discrimination. Such discrimination is becoming rampant even in the grant of bonus and other benefits.

Unfortunately the CG employees have been given an upper hand and we have been subjected to a step-motherly treatment regardless of the fact that the quantum of work we discharge is much more and leave and other benefits to us are less.

The uncertainty in granting allowances and arrears is still looming fearsomely large before us and causing nerve-wracking apprehensions yet we have not shown any curtailment of our work taking nation's interest before everything else.

Hence it is high time we stood together shedding all partisan interests to protest against this injustice and discrimination. Any attempt to push us to fringes must be vehemently resisted so as to safeguard our constitutional rights. In this juncture AINVSA calls up on all the employees to stage a **Black Badge Protest** on **17<sup>th</sup> February,2018** if the our benefits are not accorded to us.
