AINVSA laments and extends its heart felt condolences over the recent suicide of a girl student at JNV Nandurbar-I (MS),Pune Region on 18<sup>th</sup> Jan, 2018. May the almighty give strength to her bereaved family, her near and dear ones, especially the parents to bear this irreparable loss., and the Staff of JNV Nandurbar, as well,to cope up with this.

AINVSA has come to know of the manhandling of JNV staff, the political and community unrestness over it; the police protection , the declaration of BANDH for a few days, in the town etc. NVS ought to know that the life and property of JNV Staff is at stake if such an incident takes place. The innocent staff had to pay for it, whatsoever the cause of it. Its not only that , no new student would dare to study in NVS, if there is no proper system and mechanisms from above or not followed in true spirits at JNV level, but even new direct recruits would not join NVS if their life is at stake, by such repercussions. The appointment of Regular Wardens and not temporary Caretakers or Wardens, is the need of the hour; the present scenario demands it, as pointed out by AINVSA persistently, but sidelined. We once again emphasize to appoint Wardens exclusively for it as directed by CBSE, RTE Act etc to separate teaching works with much other responsibility. The adolescent students require a full time Regular wardens to take care of them.. Hence, NVS ought to reconsider this Warden issue and do the essential procedure and seek approval from the concerned for the appointment of wardens , instead of caretakers/matrons for all JNVs.
